BASIC ORDERING AGREEMENT

ARTICLE 1 - SCOPE OF WORK

The Period of Performance of this BOA, under Mod. No. 3 unless sooner reduced, terminated, or extended in accordance with the terms and conditions of this BOA, shall hereby be extended for five (5) years through on September 30, 2029. The product categories identified, as well as the discount levels, are applicable during the revised period of performance.

Option to Extend Term of BOA: Contractor may extend the term of this BOA by giving written notice to Seller by the date specified as the expiration date of this BOA. The exercise of an option to extend the term of this BOA shall be accomplished by a unilateral written modification issued by Contractor. The term of this BOA may be extended pursuant to this clause for up to one year beyond the initial term.

ARTICLE 3 - FIXED PRICES/ DISCOUNT SCHEDULE

The Contractor shall be entitled to purchase goods and/or services listed in Attachment A at the fixed prices and/or discount schedule identified in Attachment A. The prices and/or discounts identified in Attachment A are firm for the effective period of performance of this BOA, unless otherwise agreed by the Parties.
