and
GRAINGER INDUSTRIAL SUPPLIES

INTRODUCTION

This Modification No. 06 to Agreement No. LLNL-BOA-2006-001 is entered into by and between Lawrence Livermore National Security, LLC (hereinafter called "LLNS") and Grainger Industrial Supplies (hereinafter called "Seller").

PURPOSE

The purpose of this Modification is to revise the following portions of the Agreement:

1. *Agreement Introduction*: Revise Paragraph 2; add new Paragraph 3; renumber and revise old Paragraph 3 as Paragraph 4. Old Paragraph 4 is revised and renumbered as Paragraph 5.
2. Delete Attachment B, *Department of Energy Contractors*, and replace with new Paragraph 3 in the *Agreement Introduction*
3. Modify Attachment C, *800 Item Market Basket Pricing -- 1 October 2013 -- 31 January 2014* to incorporate Seller's GSA Contract Number per Article 2 of the Agreement.
4. Revise Article 2 – *Term* to reflect the new period of performance for the Agreement
5. Revise Article 5 – *Administrative* to incorporate new procurement representatives
6. Add a new Article 9 – *Incorporated Documents*

AGREEMENT

The parties agree to modify the Agreement in the following particular(s) only:

MODIFICATION(S) TO THE INTRODUCTION AND SCHEDULE OF ARTICLES

INTRODUCTION

Paragraph 2 is deleted in its entirety and replaced; a new Paragraph 3 is added; the old Paragraph 3 is renumbered as Paragraph 4; the old Paragraph 4 is revised and renumbered as Paragraph 5 as follows:

- "2. This BOA is for the Department of Energy Contractors having a prime contract with the DOE. A current list is available at <http://www.llnl.gov>. Contacts – ICPT Council Member & Constituent List and authorized subcontractors (providing supplies are in direct support of a prime contract) collectively herein after called "Contractors"."

- “3. This Agreement may also be used by other DOE Prime Contractors (collectively hereinafter called “Contractor”).”
- “4. The pricing is in accordance with *Article 4 - Fixed Prices.*”
- “5. *General Terms and Conditions* (01/2006) are included as Attachment D, and made a part herein.”

ARTICLE 2 – TERM

The first sentence of Paragraph 1 is deleted in its entirety and replaced with the following:

“The term of this BOA is from August 1, 2006 through February 1, 2019.”

ARTICLE 5 – ADMINISTRATIVE

The *Article* is deleted in its entirety and replaced with the following:


