INTRODUCTION

This Amendment No. 01 to Basic Ordering Agreement No. 3I-60122 is entered into by and between the UChicago Argonne, LLC on behalf of the Integrated Contractor Purchasing Team (hereinafter called "Contractor") and Anixter Inc. (hereinafter called "Seller").

PURPOSE

The purpose of this Amendment No. 01 is to, by mutual written consent of both the Contractor and Seller, to (1) extend the period of performance through September 1, 2026, (2) update ARTICLE 4 – ADMINISTRATIVE.

AGREEMENT

Therefore, the Parties agree as follows:

1. ARTICLE 2 – PERIOD OF PERFORMANCE (POP) is hereby amended in its entirety as follows:

"The Period Of Performance of this BOA, unless sooner reduced, terminated or extended in accordance with the terms and conditions of this BOA, shall commence on September 1, 2023, and end on September 1, 2026, with four potential one-year extensions per the terms below.

Option to Extend Term of BOA: Contractor may extend the term of this BOA by giving written notice to Seller by the date specified as the expiration date of this BOA. The exercise of an option to extend the term of this BOA shall be accomplished by a unilateral written modification issued by Contractor.

The term of this BOA may be extended pursuant to this clause for up to four years. Such extension may be made on a year-to-year basis or in one modification."

2. ARTICLE 4 – ADMINISTRATIVE is hereby amended in its entirety as follows:


All other terms, conditions, and provisions of the Agreement shall remain in full force and effect.
