The parties agree to modify the ICPT Basic Ordering Agreement (BOA) in the following particulars only:

Effective 11/10/2023:

**1. ARTICLE 1 – SCOPE OF WORK**

1.1. In accordance with the Supply Chain Management Center (SCMC) Agreement WS72938 modified on 09/11/2023 and affective 11/10/2023, BEA is exercising its unilateral option to extend the term of, and performance under, this BOA through 11/09/2026. This change will become effective on 11/10/2023.

**2. ARTICLE 3 – FIXED PRICES**

2.1. The prices under this agreement shall be in accordance with the pricing matrix titled, "Pricing Matrix for Rx Safety Eyewear, Rev 1," Dated 09/08/2023.

2.2. Dispensing Fee's, Onsite or Offsite, are area specific and shall be negotiated at the site or area specific level. Each ICPT member site, using this agreement shall negotiate a dispensing fee with Hoya based on location and specific needs. Current averages for dispensing fees range between \$26 and \$35 per transaction. This modification caps the per transaction dispensing fee at \$40 for any ICPT member site using the agreement.
