INTRODUCTION

This Amendment No. 03 to Basic Ordering Agreement No. 4I-31881 is entered into by and between the UChicago Argonne, LLC on behalf of the Integrated Contractor Purchasing Team (hereinafter called "Contractor") and Wildflower International, LTD. (hereinafter called "Seller").

PURPOSE

The purpose of this Amendment No. 03 is to, by mutual written consent of both the UChicago Argonne, LLC and the Wildflower International LTD, (1) extend the period of performance through September 30, 2028, (2) update the Procurement Administrator under ARTICLE 4 - ADMINISTRATIVE, and (3) modify Attachment A – Motorola Solutions Product Description and Discount Schedule.

AGREEMENT

Therefore, the Parties agree as follows:

1. ARTICLE 1 - SCOPE OF WORK is hereby amended in its entirety as follows:

"All Orders placed hereunder shall reference the number of this BOA 4I-31881 and site-specific order number as required by the specific Contractor site.

The effective term of the Agreement is through September 30, 2028.

The Seller agrees to furnish such quantities of products described herein as Contractor may order during the term of the Agreement. The Seller's obligation to each Contractor shall become effective upon acceptance of particular orders issued under the Agreement."


All other terms, conditions, and provisions of the Agreement shall remain in full force and effect.
