BASIC ORDERING AGREEMENT

AGREEMENT NO. BOA-2007-0516

This Basic Ordering Agreement (BOA) between United Rentals Inc. (hereinafter "Seller") and B&W Y-12, L.L.C is entered into to provide construction equipment rental and supplies to DOE/NNSA Contractors and authorized subcontractors in accordance with the following:

1. This Agreement includes products listed in **GSA Contract No. CS-06F-0068R (Expires July 31, 2015)**
2. This Agreement is for the Department of Energy and National Nuclear Security Administration contractors named in Attachment A and authorized subcontractors. This Agreement may also be used by other DOE/NNSA Price Contractors (collectively herein after called "Contractor"). GSA pricing may only be offered to those contractors and subcontractors that provide a GSA Authorization Letter to United Rentals Inc.
3. The pricing is in accordance with **GSA Contract No. GS-06F-0068R**.
4. General Terms and Conditions (CI Apr 2013) are made a part herein.

The parties agree that Contractors may place orders under this BOA and receive the appropriate discounted price. Each DOE/NNSA Contractor shall place its own orders under this Agreement and shall be direct-billed accordingly.

ARTICLE I - SCOPE OF WORK

All Orders placed hereunder shall reference the number of this BOA (**Agreement No. BOA-2007-0516**) and Order Release No. (insert release no.) as required. **Effective term of Agreement: July 1, 2007 through June 30, 2015.**

The Seller agrees to furnish such quantities of products or services described herein as Contractor may order during the term of this Agreement. The Seller's obligation to each Contractor shall become effective upon acceptance of particular orders issued under this Agreement.

ARTICLE 2 - DELIVER/PAYMENT

The work specified in Article I shall be completed and delivered as follows:

- F.O.B. Point Origin
- Payment Terms: Prompt payment discount or Net 30 days from receipt of a proper invoice
- Delivery location and schedule shall be negotiated for each order under this BOA.

ARTICLE 3 - PRICING

The Contractor shall be entitled to purchase goods and services listed in GSA Contract No. GS-06F-0068R and at the rates set forth therein, as such GSA contract may be modified from time to time. The prices identified in GSA Contract No. GS-06F-0068R, which expires July 31, 2015, shall stay consistent with the GSA schedule and are firm for the effective period of this Agreement described in Article I, Scope of Work, unless the Contractor is otherwise notified. The Seller reserves the right to change any price provided that written or electronic notification is provided to the Contractor 30 days in advance of such change.
