FAR 52.212-4 Contract Terms and Conditions – Commercial Items (Termination for Convenience and Default Provisions in (I) and (m) only are modified as follows:

SLAC may terminate this agreement in accordance with FAR 52.212-4 (I) with a five (5) month notice of termination with sixty (60) days of continuity.

Except to the extent changed by this Modification or to the extent rendered inconsistent herewith, all of the terms and provisions of this ICPT Basic Ordering Agreement remain unchanged and continue in full force and effect.
