1.0 INTRODUCTION

This Basic Ordering Agreement (BOA) between Fisher Scientific Company, LLC (Vendor, hereinafter "Seller") and Battelle Memorial Institute, Pacific Northwest Division (hereinafter referred to as "Contractor") is entered into to provide products and services to Department of Energy (DOE) Contractors and authorized Subcontractors in accordance with the terms and conditions contained in the original BOA awarded by Battelle Memorial Institute, Pacific Northwest Division.

2.0 AGREEMENT

- 1) Article 3, DELIVERY / PAYMENT, contained in the original Agreement is deleted and the following is substituted therefore:

"The work specified in Article 1 shall be completed and delivered as follows:

- F.O.B. Point (point of delivery): Destination, standard ground freight is paid by Seller for deliveries to locations within the contiguous United States. Contractor is responsible for freight charges for deliveries outside of the contiguous United States and any expedited or special shipping or handling.
- Payment Terms: Net 30 from receipt of an accurate invoice.
- Delivery location and schedule shall be negotiated for each order under this BOA.
