**INTRODUCTION**

This Modification No. One (1) to Basic Ordering Agreement No. 8I-30019 is entered into by and between the UChicago Argonne, LLC on behalf of the Integrated Contractor Purchasing Team (hereinafter called "Contractor") and Clarivate Analytics (US) LLC (hereinafter called "Clarivate" or "Seller").

**PURPOSE**

The purpose of this Modification No. One (1) is to by mutual written consent of both the UChicago Argonne, LLC and Clarivate to revise the Administrative Representatives, to extend the period of performance through December 30, 2027, update Attachments A, B and C.

**AGREEMENT**

Therefore, the Parties agree as follows:

1. ARTICLE 1 - SCOPE OF WORK is hereby amended in its entirety as follows:

"All Orders placed hereunder shall reference the number of this BOA 8I-30019 and individual Awards by sites participating.

The effective term of the Agreement is through December 30, 2027.

The Seller agrees to furnish such quantities of products or services described herein as Contractor may order during the term of the Agreement. The Seller's obligation to each Contractor shall become effective upon acceptance of particular orders issued under the Agreement."
